You will be refused entry or asked to leave this venue if you are:

- intoxicated
- violent
- quarrelsome
- disorderly
- smoking on premises
- use or possess prohibited drugs

If you are refused entry or asked to leave for being intoxicated, violent, quarrelsome or disorderly, you must:

- leave the venue immediately
- leave the vicinity of the premises (more than 50 metres)
- not re-enter or attempt to re-enter the premises within 24 hours
- not re-enter the vicinity of the premises for six hours

If you don't comply, you're committing a crime.
